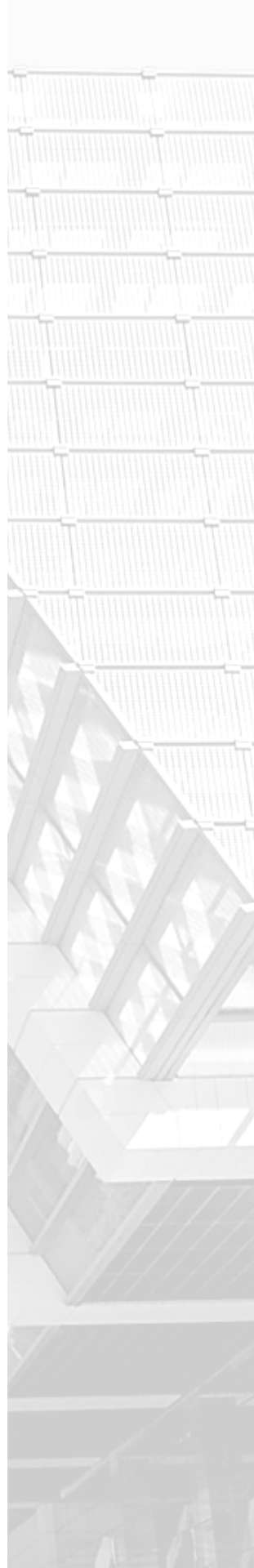

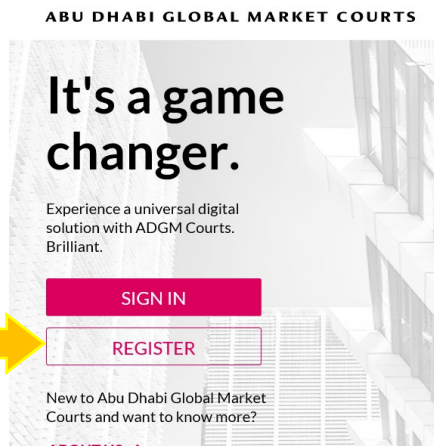

How to register

- Click [here](#) to navigate to the ADGM eCourts Platform.

- Click on **REGISTER**



- Complete the registration page with your details. Enter your email address and select **send OTP**.

- Retrieve the OTP from your email. Enter the OTP and select **validate**
