REGISTRATION AUTHORITY CIRCULAR NO. (2) OF 2022: preventative measures for events, tourism attractions, social events, and non-vaccinated individuals on AL Maryah Island (non-vaccinated updates)

This circular replaces Registration Authority Circular No. (1) of 2022, and updates preventive measures for the non-vaccinated category.

This circular is to inform all Abu Dhabi Global Market (ADGM) licensed hotels, tourism establishments, event organisers and owners, and cultural and entertainment venues in the ADGM Financial Free Zone (Al Maryah Island), of the following are health and safety preventative and precautionary requirements applicable in the ADGM.

Section 1 –Events

1. Use of Green Pass for entry, or a negative PCR test result received within 48 hours for the non-vaccinated individuals.
2. Optional wearing of face masks in outdoor spaces. Face masks required to be worn in indoor spaces. Physical distancing to be observed.
3. Operating site capacity to not exceed 90%.

Section 2 – Social Events, such as Weddings and Parties and Private Events

4. Use of Green Pass for entry, or a negative PCR test result received within 48 hours for the non-vaccinated individuals.
5. Optional wearing of face masks in outdoor spaces. Face masks required to be worn in indoor spaces. Physical distancing to be observed.
6. Operating site capacity to not exceed 90%.

Section 3 – Tourism Attractions

7. Use of Green Pass and EDE scanners for visitors' and employees' entry, or a negative PCR test result received within 48 hours for the non-vaccinated individuals.
8. Optional wearing of face masks in outdoor spaces. Face masks required to be worn in indoor spaces. Physical distancing to be observed.
9. Operating site capacity to not exceed 90%.

The above requirements and are effective from 18 March 2022 until further notice. In case of any conflict with any previous Registration Authority circular, the above requirements shall supersede those in the previous circular.

The Registration Authority monitors adherence with these requirements.

Non-compliance with these requirements may result in regulatory action including financial penalties starting from USD 800 and up to USD 10,000 and/or commercial licence cancellation.
